SHALL THE TOWN OF CHELSEA, PURSUANT TO 32 VSA ,SECTION 3840, VOTE TO APPROVE AN ADDITIONAL PERIOD OF TAX EXEMPTION TO EXEMPT FROM ALL PROPERTY TAXATION, INCLUDING ALL MUNICIPAL AND EDUCATIONAL TAX LIABILITY, FOR FIVE YEARS, COMMENCING IN 2025, ON THE CURRENT CHELSEA HEALTH CENTER FACILITY, AND 2.5 ACRES OF LAND ON WHICH THE FACILITY, PARKING LOT AND DRIVEWAY ARE SITUATED, LOCATED AT 365 VT RTE 110 IN THE TOWN OF CHELSEA, OWNED BY THE CHELSEA HEALTH CENTER, INC, A NON-PROFIT ORGANIZATION USED PRIMARILY FOR PUBLIC HEALTH PURPOSES.
